Presiding Commissioner Bob Cirtin called the meeting of September 21, 2016 to order.

Informational Items

Information Systems—Jess Kerr

Mr. Kerr reported Phase I of the camera installation at the Greene County Jail has been completed.

Mr. Kerr gave an update on the Highway Patrol computer system. The Highway Patrol is now able to send fingerprints on the current website for suspect identification.

Mr. Kerr stated the Greene County website is operating well.

Commissioner Harold Bengsch and Jennifer McClure both completed Information Systems on navigating through some computer issues.

Purchasing Department—Chris Mericle

Mr. Mericle presented the Commission with a monthly report (Exhibit A).

Mr. Mericle will be meeting with Dan Patterson, Greene County Prosecuting Attorney, and Kevin Barnes, Resource Management Director, to define the Prosecuting Attorney's office move to the Cox Tower Building.

The Collector's office is in the process moving a desk in the customer area of their office. The remodel will be funded through the Collector's fund. The General Revenue fund will not be accessed for this project.

Mr. Mericle stated there have been several bidders for inmate supplies which should result in a savings for this purchase.

Mr. Mericle informed the Commission that Juvenile health service rates have been reviewed and that Cox Health Systems has proved to be less expensive.

Mr. Mericle sought direction from the Commission regarding paying established billings (i.e. utility statements) with credit cards. Using credit cards for this type of payment will create rebate funds and result in a savings for Greene County. The Commission agreed to allow this practice for payment of appropriate billings to be paid by credit card.

Mr. Mericle has been researching free bidding software. Free online bidding may not be as cost effective depending on how the bidding is monitored.

Mr. Mericle stated he is reviewing services from Garda which is a cash courier. The Collector's office has had difficulty with Garda charging separate fees if the company picks up cash bags at different locations in the building. The Collector subsequently went to a one location stop resulting in Garda charging for the number of bags. The Collector combined the bag content and Garda began charging the bags by weight. Garda drivers are not insured. Garda charges a cancellation fee but the county would be able to recuperate by using a local service. Mr. Mericle is negotiating to have the cancellation fee removed, which was not listed in the original agreement.

Mr. Mericle gave an Employee Appreciate Day event update. The committee has chosen a T-shirt to be the employee gift for the event.

Mr. Mericle updated the Commission on upcoming bids with regard to the Greene County Highway Department purchases.

Chris Coulter

Mr. Coulter updated the Commission on the Planning and Zoning Hearing held Tuesday, September 20, 1016. There was a Halloween event denied as well as a truck terminal on property located at I44 and Farm Road 129.

There was a discussion of Archive and Election Center reservation scheduling.

There was a discussion of the content of legislative priorities to present to Southwest Missouri Legislators. The Commission will meet Friday, September 30, 2016, from 9:00 a.m. to 10:30 a.m. to discuss legislative priorities.
