Present: Bob Dixon, Harold Bengsch, John Russell, Captain Johnson, Major Denny, Dean Cary, Chris Coulter, Franz Williams, Mailyn Jeffries, Amanda Corcoran, Kami Johnson, Miriam Minter, Chris Mericle, Laura Merriman, Michelle Hunt, Rod Ron, Derris Butler, Tim Connell, Jeff Scott, Tina Phillips, Mike Cagle, Donna Barton and Megan Applegate.

Major Denny explained to the Commission that the Sheriff's Office is in possession of a van with 190,000 miles on it that they are seeking approval to sell. The van was originally going to be put on GOV deals however Ozark County Sheriff's office had a desperate need for a new transport vehicle. \$4500.00 is what the van would be sold for to Ozark County upon the Commission's approval. Commissioner Dixon asked if it was customary to sell to other entities vs GOV deals. Major Denny explained that in a situation where another county is in need of a piece of equipment it will be offered to the county in need. Denny explained that selling on GOV deals would not be sold for a higher price. Commissioner John Russell moved to approve the sale of the van to the Ozark County Sheriff's Office for \$4500.00. Commissioner Harold Bengsch seconded the motion and it was unanimously approved. Aye: Dixon, Bengsch and Russell. Nay: none Abstain: none Absent: none

Buyer Miriam Minter from the purchasing office presented the Commission with a sole source purchase. (Exhibit 1) The sole source provider was Gatekeeper Proprietary Software which provides video surveillance equipment for transport vehicles, the company will also at no charge include and extended warranty. Commissioner Russell asked how many vehicles will have the equipment. Quarter Master Carey stated that 12 vehicles will receive the new equipment. Commissioner Bengsch moved to approve the sole source purchase to Gatekeeper Proprietary Software. Commissioner Russell seconded the motion and it was unanimously approved. Aye: Dixon, Bengsch and Russell. Nay: none Abstain: none Absent: none

Purchasing Director Chris Mericle provided the Commission with the bid pricing for the Justice Center and Archives Roof re-cover. (Exhibit 2) Kirberg was awarded the bid, Mericle explained some of the options and price points offered by Kirberg. Discussion of options for TPO MM ensued. It was decided that the 80 MM TPO option was best for the county. The Justice Center will come over budget at about 8-9k dollars. The recorder will pay for the archives roof re-cover. Commissioner Bengsch moved to approve and award Kirberg the re-cover bid with the 80 MM options. Commissioner Russell seconded the motion and it was unanimously approved. Aye: Dixon, Bengsch and Russell. Nay: none Abstain: none Absent: none

Purchasing Director Chris Mericle provided the Commission with the award letter for the Workers' Compensation Bid. (Exhibit 3) Mericle summarized the letter, Connell Insurance has been awarded the bid. Commissioner Russell thanked the committee for their effort and time in the process. Commissioner John Russell moved to approve the award to Connell Insurance for the Workers' Compensation Insurance. Commissioner Harold Bengsch seconded the motion and it was unanimously approved. Aye: Dixon, Bengsch and Russell. Nay: none Abstain: none Absent: none

Purchasing Director Chris Mericle provided the Commission with a P&C quote comparisons/recap highlight sheet from BPJ. (Exhibit 4) Mericle explained that Chubb had the lowest premium for property Insurance. MOPerm was the lowest premium for auto insurance and States offered the lowest premium for general liability. Rod Ron from BPJ gave a brief explanation to the commission on each insurance as well as other options that could be included in the auto option. Ron explained that the county could pay for an auto catastrophic option that would cover the loss of a loss where several vehicles were parked in one area and destroyed. Upon discussion it was stated that there are not many areas in the county that have mass amount of vehicles parked at one time with exception to the Highway department which has never experienced a mass loss. Commissioner Russell stated that based on the fact that no claims have ever neem made on the auto catastrophic option and the likely hood of an occurrence it was not necessary to pay for the option. Ron also explained an optional recommendation for the next year of cyber liability. Commissioner Bengsch asked if other entities similar to the county had the option. Ron explained that the City of Springfield has coverage as well as City Utilities. Commissioner John Russell moved to approve Chubb option 1 for property insurance and to decline the auto catastrophic option, and to approve State insurance option 1 for public entity liability insurance and to approve MOPerm for auto insurance. Commissioner Harold Bengsch seconded the motion and it was unanimously approved. Aye: Dixon, Bengsch and Russell. Nay: none Abstain: none Absent: none The Commission also directed the broker BPJ to look into cyber liability insurance for the future.

Budget Officer Jeff Scott informed the Commission that his office as contacted by Dan Patterson the Prosecuting Attorney. Two computer located in Mr. Patterson's office need replaced, due to the funds coming out of LEST II and the purchase not being approved in the original budget it will need to be approved by the Commission. Commissioner Harold Bengsch moved to approve the computer replacement out of LEST II. Commissioner John Russell seconded the motion and it was unanimously approved. Aye: Dixon, Bengsch and Russell. Nay: none Abstain: none Absent: none.

Budget Officer Jeff Scott presented the Commission with the monthly transfer letter. (Exhibit 5) Commissioner Harold Bengsch moved to approve the signing of the monthly budget transfers. Commissioner John Russell seconded the motion and it was unanimously approved. Aye: Dixon, Bengsch and Russell. Nay: none Abstain: none Absent: none.

Executive Assistant Megan Applegate presented the Commission with a letter (Exhibit 6) for Mary Ann Rojas the Executive Director of the Workforce Development Board. The letter was for recommendation by the Commission to appoint Steve Dooley to the board. Commissioner John Russell moved to approve the letter of recommendation for appointment of Steve Dooley. Commissioner Harold Bengsch seconded the motion and it was unanimously approved. Aye: Dixon, Bengsch and Russell. Nay: none Abstain: none Absent: none.

Deputy Budget Officer Tina Phillips provided a hand out to the Commission in regards to sewer accounts. (Exhibit 7) Phillips gave a 2018 summary and current summary of sewer accounts. Budget Officer Jeff Scott reminded the Commission of the upcoming Bond conference call that will take place on the 27th at 1:00 pm. Scott also reminded the Commission of a Tax Oversite Meeting that will take place in April. Scott is working with HR to obtain information to check the possibility to hire the Inmate Medical Services staff as Greene County employees. HR is working to see what the salary grades would be to add these people as employees as well as the cost of benefits. The fugitive apprehension unit will need 6 vehicles explained Scott, this is

something that Mr. Scott will come forward at another briefing so that the Commission can vote on the item. Captain Johnson from the Sheriff's Office asked Scott if the budget for the jail which had been presented at a meeting the prior day was accurate, Major Denny asked Mr. Scott if Ms. Stein the Auditor and Mr. Hill the Treasurer were included in creating the jail budget or if they had the opportunity to look over the numbers that were presented. Scott stated he had spoken with them briefly. Scott went on to highlight some numbers from the meeting.

HR director Mailyn Jeffries updated the Commission on Medical Marijuana time line in the state of Missouri.

County Administrator Chris Coulter informed Commission that the director of the Red Cross requested to come to a Commission Briefing and introduce themselves.

With no other business the meeting was adjourned.
