

### Informational Items

Pre Trial Supervisor Natalie Gomez gave an update on numbers to the Commission. 169 Bond studies ordered in July compared to 16 Bond studies ordered during the same time in 2018. 241- Bond studies ordered since 7/1/19. 239- Defendants currently under Pretrial supervision. 66- Defendants currently on GPS/SCRAM supervision. 17,000- Spent on GPS/SCRAM units for July 2019. 75,000-Spent on GPS/SCRAM units from 1/1/19-7/31/19(amount budgeted for 2019). Gomez explained that they are seeing defendants released OR, and with a lowered bond both released to Pretrial supervision, and both being ordered to have GPS/SCRAM monitoring. However, the number of those that have posted a monetary bond appears to be very low. August numbers seem to be similar to July.

Purchasing Director Melissa Denney provided a monthly status report for August 2019. Denney highlighted reports which included: bids, contract renews and other upcoming items.

Director Jess Kerr informed Commission of projects that his staff are working on around the county. Kerr and staff are meeting with the jail advance team to look over the jail construction plan. IS is working on a standard user account on personal office computers, which protect against malicious malware.
