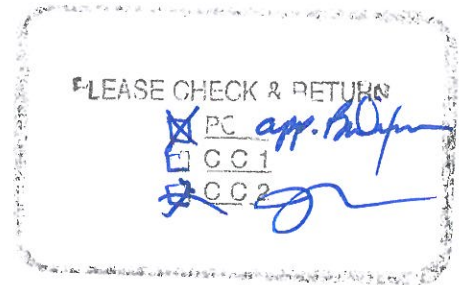


This letter is to confirm that:


