# IRREVOCABLE PETITION AND CONSENT TO ANNEXATION

This Irrevocable Petition and Consent to Annexation, made and entered into this 2/4 day of 2020, by and between Greene County, Missouri, a county of the first class without a charter form of government, hereinafter referred to as "Grantor," and The City of Springfield, Missouri, a Municipal Corporation and duly organized Constitutional Charter City, of the County of Greene, State of Missouri, hereinafter referred to as "Grantee." The mailing address of the Grantor(s) is 1443 N. Robberson Ave., 10th Floor, Springfield, MO 65802. The mailing address of the Grantee is City of Springfield, Department of Public Works, 840 Boonville Ave., Springfield, MO 65802.

KNOW ALL PERSONS BY THESE PRESENTS THAT: The Grantor(s), for and in consideration of the provision of sanitary sewer services, being the owner of all of the fee interest in the real properties commonly known as Parcel ID: 88-14-13-100-004, and more fully described as follows:

A PART OF THE NORTHEAST QUARTER OF SECTION 13, TOWNSHIP 29 NORTH, RANGE 23 WEST, GREENE COUNTY, MISSOURI, BEING MORE PARTICULARY DESCRIBED AS: COMMENCING AT THE NORTHEAST CORNER OF SECTION 13; THENCE SOUTH 02 DEGREES 19 MINUTES 35 SECONDS WEST ALONG THE EAST LINE OF THE NORTHEAST QUARTER 76.30 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING SOUTH 02 DEGREES 19 MINUTES 35 SECONDS WEST ALONG SAID EAST LINE 1725.52 FEET TO THE NORTHERLY RIGHT-OF-WAY OF BURLINGTON NORTHERN RAILROAD AS NOW LOCATED: THENCE NORTH 77 DEGREES 47 MINUTES 11 SECONDS WEST ALONG SAID RIGHT-OF-WAY 686.89 FEET; THENCE NORTH 00 DEGREES 12 MINUTES 22 SECONDS EAST DEPARTING SAID RIGHT-OF-WAY 820.66 FEET: THENCE SOUTH 89 DEGREES 47 MINUTES 38 SECONDS EAST 238.23 FEET; THENCE NORTH 00 DEGREES 12 MINUTES 27 SECONDS EAST 809.17 FEET TO A POINT ON THE SOUTHERLY RIGHT-OF-WAY OF MISSOURI STATE HIGHWAY "EE" AS NOW LOCATED; THENCE SOUTH 88 DEGREES 21 MINUTES 58

SECONDS EAST ALONG SAID RIGHT-OF-WAY 348.90 FEET; THENCE SOUTH 71 DEGREES 17 MINUTES 31 SECONDS EAST ALONG SAID RIGHT-OF-WAY 125.16 FEET; THENCE SOUTH 89 DEGREES 49 MINUTES 27 SECONDS EAST ALONG SAID RIGHT-OF-WAY 29.98 FEET TO THE POINT OF BEGINNING, CONTAINING 23.00 ACRES, MORE OR LESS.

does hereby irrevocably petition and consent to the future annexation of said property in the corporate limits of the City of Springfield, Missouri, Grantee herein.

At such time as the City Council of the City of Springfield may by resolution or ordinance declare that annexation is in the interest of the City of Springfield, Grantor and Grantor's heirs, legal representatives, successors and assigns, shall cause this petition to be presented to the governing body of the City of Springfield, and do all things necessary to meet the requirements of the State Annexation Statutes to cause such property to be annexed into the City.

Provided, however, that annexation of the property will not be effective until such time as sewer service is available to the property.

Any objection to such annexation filed by Grantor(s), by any succeeding property owner(s), or by any occupant or resident of the property, shall relieve the City of any obligation to provide sewer service to the property, and the City may thereafter, upon reasonable notice, terminate sewer service and disconnect the property from the City of Springfield's sanitary sewer system. It is expressly stated and understood by Grantor(s) that but for the execution of this irrevocable consent to annexation and the commitment of Grantor(s) to do all things necessary to complete the annexation at such future date, the City would not extend sewer service to the real estate described in Exhibit A and any objection to annexation shall constitute complete and total failure of consideration for extending sewer service to property outside the City's limits in advance of annexation.

Failure to consummate annexation at any time during the term of this Irrevocable Petition and Consent to Annexation shall not cause this Petition and Consent to lapse and the same shall continue in full force and effect until such time as annexation is fully and lawfully consummated.

In the event of any breach or default by Grantor(s), this Irrevocable Petition and Consent to Annexation shall be enforceable by specific performance and, if litigated, venue shall be proper only in the Circuit Court of Greene County, Missouri. The parties expressly waive any rights to venue inconsistent herewith, and agree attorney's fees will be reimbursed to Grantee.

This Irrevocable Petition and Consent to Annexation shall be deemed to be a covenant running with the land to succeeding owners and shall be deemed to be the Petition and Consent to Annexation of succeeding owners, their heirs, legal representatives, successors, and assigns until annexation is fully lawfully consummated as in this instrument provided.
