Reappointment Procedures:

- Please do not contact the member to ask if they are willing to continue to serve on the board.
 This will be handled through the Commission office.
- If a board member's position is due to expire, but is eligible for reappointment, please contact Aubrey Hardy to confirm if the board wishes to have the person continue membership.
- If the Commission approves the reappointment, the Commission office will contact the member to confirm their desire to continue membership.
- At this time the Commission will schedule a reappointment date.
- The Commission office will notify the board chair of the reappointment date.
