Dear Mr. Chairman and Commissioners:

We would strongly encourage the MHDC to grant Trinity Housing Development's request for Low-Income Housing Tax Credits in support of their Ashford Place development.

If approved, Ashford Place will be a great asset for the Republic community, which is one of Missouri's fastest-growing cities. This development will include 40 units for families earning between 50% and 80% of the Area Median Income, with a special emphasis on targeting veterans and their families.
