Subject: Action Item to Return additional funds to MHDC

The County entered into a sub-grantee agreement with the Missouri Housing Development Corporation effective February 1, 2022 for the purpose of distributing Emergency Rental Assistance funds. That agreement was amended effective August 1, 2022 and extended the use of the funds to October 31, 2022. On November 22, 2022, the County Commission approved the Emergency Rental Assistance Missouri Settlement Letter.

Since November 22, 2022, the County has received four checks back from City Utilities of Springfield, totaling \$512.31. These funds represent partial awards for future utility expenses made by Consumer Credit Counseling Service where the tenant left the residence before all of the award funding was used. Since the program ended as of October 31, 2022, the County will not be redistributing the funding back to Consumer Credit Counseling Service.

- 1) Commission is requested to authorize the return of the \$512.31 of sub-recipient funds to the Missouri Housing Development Corporation.
- 2) In order to balance the commitments and awards Commission is requested to reduce the commitment of funds to Consumer Credit Counseling Service by \$512.31.
