Commissioner Dixon called the meeting to order.

The first item on the agenda was a discussion and possible vote regarding a state audit. Commissioner Hough explained that he worked with county counsel John Housley to write an order (Exhibit A) to request the State Auditor to perform an audit of Greene County. Commissioner Hough made a motion to adopt the order and Commissioner Dixon seconded the motion for discussion. Commissioner Bengsch noted that the order mentioned cost for the audit, which was a deviation from the proposal that the State Auditor made of doing the audit for free. Commissioner Bengsch asked what the cost would now be. Commissioner Hough said that, looking at the Camden County audit and similar county audits, it would probably be in the area of \$150,000.

Commissioner Dixon said that he has confidence in county staff, but he agrees to move forward with an audit in order to assuredly restore the public's trust. He did not agree to the wording on Commissioner Hough's proposed order of "a comprehensive audit." He said he'd prefer to at least allow the State Auditor access at a high level to check overall, and then if they see something they can delve deeper but that there was no need to run the cost up unless a higher level check indicated a need for a more comprehensive look. Upon further discussion, it was also clarified by county counsel John Housley that the audit would be evenly conducted on all county offices and not focused on any particular office. Commissioner Dixon acknowledged that the audit would impact the work load and logistics for county staff and operations, and requested that the order include a request that the State Auditor staff use their own location on Park Central Square to conduct the audit work. He also asked that the order be revised to request that the state audit commence upon the completion of the external audit being conducted by KPM. Housley suggested talking to the State Auditor about the timing and office space requests. Commissioners Bengsch and Hough agreed with Commissioner Dixon about the timeline suggestion. It was agreed that Housley would make the following changes to the order during the meeting:

- Wording to request a timeline to commence the state audit after the fieldwork for the external audit is complete.
- A request that the State Auditor staff use their own office space (on Park Central Square.)
- Remove the word "comprehensive" and make the grammatical change of "a" to "an" in the same sentence.

Commissioner Hough amended his motion to adopt the amended order. Commissioner Dixon seconded the amended motion. Commissioner Bengsch said that, while he wasn't sure that the audit was necessary, he felt it was time to show unity among the commission and would support the motion. The motion passed unanimously.

Commissioner Hough also raised for discussion and possible vote the authorization to advertise and bid for health insurance and worker's compensation coverage for county employees. Commissioner Dixon had several questions regarding health insurance. HR Director Mailyn Jeffries stated that she would prefer to be able to meet with the Commissioner to explain the county's health insurance prior to a vote taking place. Commissioner Bengsch stated that this was not a decision that should be made that day and should wait until all three commissioners (including the incoming Dist. 2 Commissioner) are seated. Commissioner Hough made a motion to authorize staff to advertise and bid for health insurance and worker's compensation. Commissioner Dixon suggested taking health insurance out of the motion and proceed with advertising and taking bids for worker's compensation. Commissioner Hough was open to the suggestion and Commissioner Bengsch supported it. Commissioner Hough amended his motion to only pertain to worker's compensation. Commissioner Dixon seconded the motion. The motion passed unanimously.
