This afternoon and tonight:

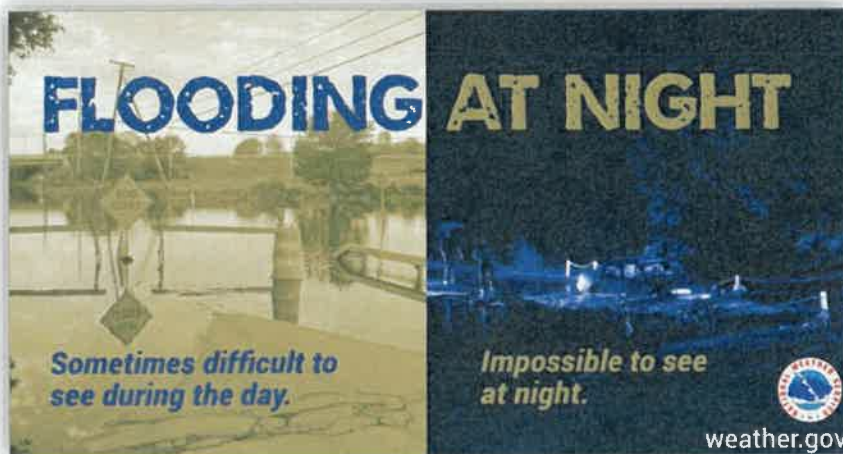
Residual flooding will continue across much of the area into tonight due to recent heavy rainfall. Several low water crossings remain underwater.

Operation: Sling Blade | Full-Scale Exercise

Springfield-Branson National Airport

On Wednesday, May 19th, the Springfield-Branson National Airport and OEM conducted a full-scale exercise. This exercise, titled "Operation: Sling Blade", was designed to test the capabilities of local, state, federal, and non-governmental agencies during an integrated Response. The purpose of this exercise was to evaluate player actions against the Springfield-Greene County Emergency Operations Plan, as well as agency policies and protocols in response to a mass casualty incident as a result of a commercial plane crash at the airport.

Shift in Territories Coming July 1

Historically, Red Cross units in all lines of business (including Disaster Services) have followed chapter-based geographic boundaries. 


