MAN SENTENCED TO 32 YEARS FOR SHOOTING STRANGER

SPRINGFIELD, Mo. – Greene County Prosecuting Attorney Dan Patterson announces that David Junior Cox, 54, was sentenced today for a shooting that occurred in September of 2015. David Cox led police on a chase through Republic and into Springfield. The chase came to an end at Republic Road and Scenic where the defendant got out of his vehicle that had been disabled by stop sticks. He ran towards a truck nearby that was occupied by the victim and shot the victim in the chest in an attempt to rob him of his truck.

The defendant had prior felony convictions for forgery, theft, kidnapping, aggravated escape from custody, burglary, and aggravated robbery. The defendant was paroled from the Kansas Department of Corrections four months prior to this assault.

Cox was sentenced by The Honorable Calvin Holden to 32 years in the Missouri Department of Corrections for charges contained in the felony information.

In Count 1 charging Assault 1st degree - serious physical injury for events that took place on or about 09/09/2015, the defendant was sentenced to 25 years. In Count 2 charging armed criminal action, the defendant was sentenced to 10 years. In Count 3 charging Robbery 1st Degree, the defendant was sentenced to 25 years. In Count 4 charging armed criminal action, the defendant was sentenced to 10 years. In Count 7 charging Resisting arrest, the defendant was sentenced to 7 years. In Count 8 charging Leaving Scene of Motor Vehicle Accident, the defendant was sentenced to 7 years.

Counts 1 through 4 were concurrent to each other. Counts 7 and 8 were concurrent to each other but consecutive to Counts 1 through 4.

Counts 5, 6, and 9 were dismissed to induce the defendant to plead guilty but there was no plea agreement with regard to the term of years for Counts I-4 and 7-8.

This case was investigated by the Greene County Sheriff's Office and Detective Blaine Kennard was the lead investigator assigned to the case.

PROBABLE CAUSE STATEMENT

I, BLAINE V KENNARD, knowing that false statements on this form are punishable by law state as follows:

1. I have probable cause to believe that DAVID JUNIOR COX, White/Male, DOB 05/ /1962, committed one or more criminal offenses.

2. The following crime(s) happened on 2015/09/09 06:18 – 2015/09/09 07:30 at S CANTON AVE and W FARM ROAD 146 RD in Greene County, Missouri.

3. The facts supporting this belief are as follows:

On September 9, 2015, at approximately 0618 hours, Greene County Sheriff's Deputies became involved in a pursuit with a black in color, 2006 Pontiac G6. The Pontiac displayed Missouri license plate HL2-Y1X on the rear of the vehicle and DK6-W6C on the front of the vehicle. The driver of the Pontiac was later identified as David Junior Cox, D.O.B. 05 / 1962. A female passenger was also located in the front passenger's seat of the vehicle. She was later identified as Marie Ann Hamm, D.O.B. 09 / 1983.

Greene County Sheriff's Deputies were conducting targeted enforcement with-in the residential neighborhoods due to the increase in vehicle break-ins. A Deputy observed the black Pontiac traveling in the neighborhood with it headlights turned off. When he attempted to initiate a traffic stop on the vehicle, it fled the area. The vehicle also matched the description of a vehicle, a black passenger car with heavy rear bumper damage, where a male subject pointed a gun at a clerk and left the area westbound on Chestnut.

The pursuit began in the area of Farm Road 146 and Canton, an intersection located in Greene County, Missouri. Cox was being actively pursued by a fully marked Sheriff's Patrol vehicle operating with both its emergency lights and sirens. A second fully marked Sheriff's Patrol vehicle, operating with both its emergency lights and sirens, joined the pursuit in the area of Sunshine and Farm Road 115. Cox was traveling westbound on US 60, making several lane violations, braking erratically, and traveling at speeds up to ninety miles per hour. Spike strips were deployed on the vehicle which did strike at least one of the tires on the Pontiac causing the tire to deflate.

Cox continued on US 60, traveling westbound into the city limits of Republic, Missouri. The Pontiac started losing tire debris due to the flat tire on the vehicle. In the area of US 60 and Main, Republic, Missouri, Cox made a U-turn and began traveling eastbound on US 60. While on US 60, within the city limits of Republic, Cox weaved between numerous cars creating a hazard to other motorists on the roadway. During the pursuit, Cox collided into the rear end of a dark colored Dodge Ram just east of Hines. Cox left the scene of the accident and continued eastbound on US 60.



Cox continued eastbound on US 60 into the city limits of Springfield. Cox turned south onto S. Scenic from US 60, also known as Sunshine Street. Spike strips were deployed at least two other times while traveling southbound S. Scenic causing additional tires to deflate. The vehicle came to rest on the S. Scenic overpass, south of Chesterfield Boulevard.

Cox exited the driver's side of the Pontiac and approached a tan in color Dodge 4 X 4 pick-up truck displaying Missouri license plate 2YP-334 who was traveling northbound on S. Scenic. The vehicle was being operated by Gary N. Haugen. Cox reached the driver's side door, standing within approximately two feet of the driver's side door, yelling at Haugen, but Haugen could not understand what was being said to him. Haugen observed Cox to be extending his right arm as he held a silver in color revolver. Cox fired a single gunshot through the driver's side glass window, striking Haugen in the left shoulder. Haugen exited the vehicle and took cover on the opposite side of the concrete wall located on the west side of S. Scenic, separating the roadway from the sidewalk. As Haugen exited his vehicle, Cox was observed by Deputies entering the driver's side of the vehicle to further his escape. Haugen heard several additional shots fired. When he looked over the concrete wall, he observed Deputies extracting Cox from his truck, taking Cox into custody.

Haugen was transported to Cox South Emergency and Trauma Center where he was treated for a single gunshot wound. Medical personnel said the projectile entered Haugen's left shoulder and traveled through his chest cavity missing the aorta, by approximately one inch, lodging within his chest cavity. Haugen was admitted into Cox South Hospital, ICU, due to his injuries.

The facts contained above are true.

The felonies are as follows:

 On or about January 9, 1986, defendant pleaded guilty to two counts of the felony of theft in the District Court of Wyandotte County, Kansas, case number 85CR1816"A" for events occurring on October 2, 1985..
 On or about November 30, 1988, defendant pleaded guilty to the felony of theft in the District Court of Wyandotte County, Kansas, case number 88CR1324C for events occurring on June 19, 1988.
