City of Springfield Give 5 Program:

 Melissa, for the City of Springfield, was here to discuss their new Give 5 Senior Volunteer Engagement Program. Melissa stated that they will be doing social media press releases on this new program and that they also have a newsletter called Springfield Neighborhood. Melissa also said they have sent information out with City Utility bills on this program.

Denny stated that he thought using volunteers was a really good thing to do. Denny also stated that Springfield/Greene County work well together, but in pilot programs you have to see how things turn out.

After answering other questions by the Board and the Greene County Auditor the motion to approve grant request in the amount of \$24,500.00 was made by Denny and seconded by Joyce, with stipulations that they would provide corrected application funding page 3 with the corrected amount for just the last half of the year for 2017.
