

GREENE COUNTY, MO
ANNUAL TAX SALE
NOTIFICATION: I, Leah Betts,
Collector within and for Greene
County, Missouri, hereby give
notice that as a result of the
response to COVID-19, the
Greene County Collector's Office
will not be holding the 2020 tax
sale for delinquent real estate
taxes. What does this mean for
taxpayers? If properties have
delinquent real estate taxes,
those properties will not be
offered at the tax sale this year in
August. However, this does not
dismiss, postpone, or eliminate
any tax liability. Due to Missouri
State Statutes, county taxes, if
left unpaid, will still be delinquent,
accrue additional interest,
penalty, and costs as well as be
eligible for the tax sale in August
2021. We continue to urge the
public to make all efforts
necessary to get delinquent taxes
caught up to avoid the sale in
August 2021. This cancellation
does not affect any policies or
laws regarding the redemption of
any property tax liens from
previous tax sales. Please
contact our office and speak to
one of our surprisingly pleasant
staff to discuss how you can use
this extra time to get caught up
and avoid getting further behind.
We are here and happily ready to
