Treasurer's Report: Treasurer's report for October 31, 2022 was presented by Denny Pilant. Total Cash Balance as of the end of August is \$1,364,313.77. Property Tax Revenue is \$5,760.05, Bank/Investment \$1,951.96 with a Total Revenue of \$7,712.01 the YTD Revenue is \$2,760,499.97. Total Expenditures \$337,795.60 the YTD Expenditures is \$2,747,262.00 with Checks issued: Debbie Allen (2), Strafford Senior Center, Senior Age Area Agency on Aging (4th Qtr). Presentation: Senior Age Area Agency on Aging – Liz McClelland and Becca Fields

Requesting Funds in the amount of \$1,241,241.00 (same amount as requested last year). Founded in 1974, SeniorAge has been the nonprofit Older Americans Act Area Agency on Aging for 48 years, helping seniors (60+) in 17 counties of the Ozarks maintain healthy, resourceful independence and quality of life. To assure the greatest success in this mission, they embrace and address the needs of senior caregivers, as well. They also work to balance general program approaches with one-on-one care to best identify and alleviate "root" or core concerns.

This year they will continue providing traditional methods of outreach, as well as new methods of outreach initiated during the pandemic. Many changes made during the pandemic will have long-standing value for seniors and communities.

Presentation: OATS – Jeff Robinson and Lisa Baily

Requesting funds in the amount of \$502,498.00 for service provision plus \$32,292.00 for bus match for a total of \$534,790.00. The additional amount increase is due to skyrocketing national transit costs, particularly for maintenance, parts, fuel and buses. Requesting board payment of the 20% match for two (2) buses after what will be four (4) years without bus replacements due to pandemic's continuing impacts to supply and demand. The mission of OATS is enhancing quality of life by providing safe, caring and reliable transportation services. OATS Transit will provide the equivalent of sixteen (16) vehicles operating a total of approximately 18,100 hours per year for transportation of Greene County's citizens. No other like door-to-door, regularly scheduled, reservation transportation is available to seniors in Greene County. The project's primary goal is to provide additional transportation opportunities to senior citizens. The expected outcome is a greater flexibility in service and increased availability of transportation.

Motion to approve made by Bobbie Wurst for the modified amount to \$502,498.00 (which does not include the purchase of the additional buses – this is an increase from lasts years request). Seconded by Joyce Munden for the modified amount. Motion carried pending FY2023 Budget approval and submission of FY2022 Progress Report.
