 Peggy King made the motion to approve the minutes, Mary seconded. All in favor and motion passed.

Treasurer's Report: December 31, 2015

• Denny made the motion to approve the Treasurer's report, Joyce seconded. All in favor and motion passed.

Old Business:

Mercy - \$30,000; Matthew Skala signed the grant request (Krissy's copy); Mercy does not use income to determine if someone is eligible for the grant program; Mindy tells potential participants that the funds come from the Senior Tax; they will create a small handout to give to participants which specifically states the funds for the program come from the Senior Tax; no unused grant money is owed to the Senior Fund as Mercy invoices the fund after services have been rendered; unspent money remains in the Senior Tax Fund.

Joyce made the motion to grant Mercy's request, Denny seconded. All in favor and motion passed.

Southside Seniors – remained tabled as board awaits their corrected progress report.

New Business:

Jordan Valley Community Health Center - \$100,000; Jacque Morris presented demographics
and statistics sheet to accompany progress report; Brooks Miller discussed the need for
funding urgent dental needs not related to dentures; the board recommended they apply for a
separate grant to address those issues; \$11,485.50 unspent funds but appointments made to
complete dental work already started; per our contract, unspent funds must be returned;
Jordan Valley CHC will return the unspent funds.

Denny made the motion to approve the grant request in the amount of \$111, 485.50 to cover 2016 and the remaining visits scheduled from 2015, Joyce seconded. All in favor and motion passed.

• United Way Hands on for Seniors - \$35,000; T-shirts for volunteers and brochures show the source of the funding; the board requested they produce a small handout to give to seniors involved with the program.

Mary made the motion to approve, Joyce seconded. All in favor and motion passed.

• Denny made the motion to go into a closed meeting pursuant to Missouri Revised Statute 610.021.17, Peggy King seconded. All in favor and the meeting was closed.
