#### **Budget Process**

- June 2017 Budget Office conducts departmental budget training and information sessions
- June/July/August Departments work on their budget which included: Revenue, Expenses and Personnel
- September 1<sup>st</sup> Statutory deadline to submit

# Process (Continued)

- September/October Review requests and work on putting together a Recommended Budget
- November 15<sup>th</sup> Statutory deadline to present the Recommended budget to County Commission
- November 16<sup>th</sup> thru January Public Hearings with Commission regarding Recommended Budget
- January 10<sup>th</sup>/30<sup>th</sup> Statutory deadline for adoption of Appropriated Budget

#### How Much?

- All funds including Developmentally Disabled Board Fund and Library Fund - \$161,516,271
- Combined General Revenue \$53,814,452
- Amounts less court orders, grants, distributions to muni's and community organizations, Office Holder funds, and transfers.
- Total \$93,495,636 with GR \$45,086,718

- 21 new positions in the Prosecuting Attorney's Office. Expansion of the Drug Court Program.
- Family Justice Center to improve Domestic Violence Issues.
- Bringing the Medical Examiner program in-house.
- Stormwater projects with the Needmore Branch and various subdivisions.
- Tuck pointing for the Historic Courthouse.



#### What's New

- 12 Vehicles for the Sheriff's Department.
- New elevator control system for the Jail Tower .
- New election equipment.
- \$382,000 of Information Systems Equipment.
- Funding for the design of the Jail Expansion and the Operation Center Building.
- Possibility of a Bond issue to move up the Construction timeframe of the Operations Center depending on design and location.

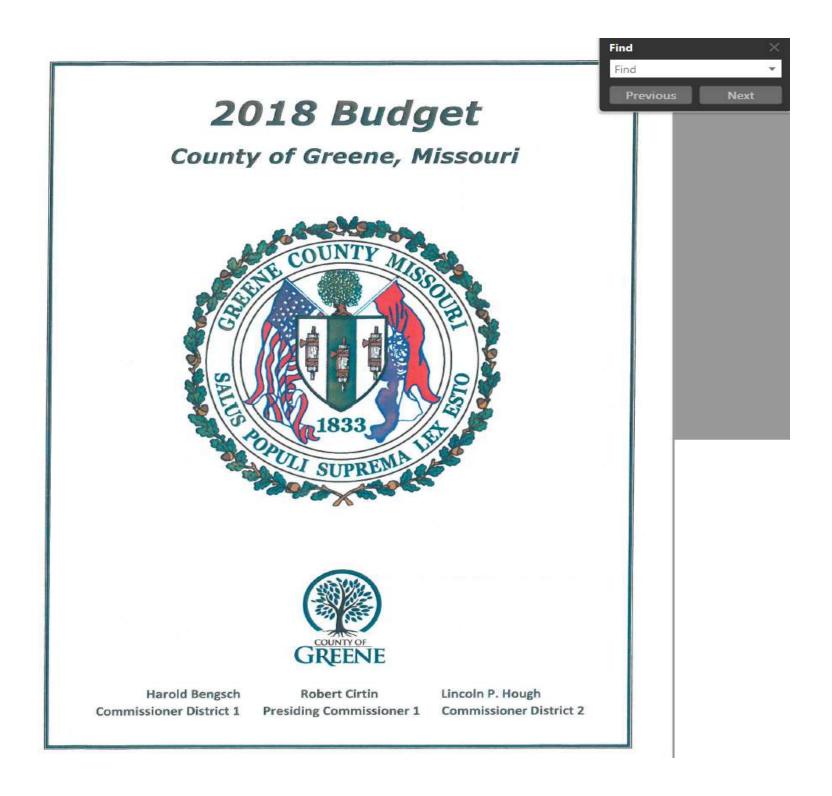
