Sales Tax Received in April 2025 (March 2025 processing)


County's General Sales Tax is <u>Down 1.42%</u> for this month compared to the same month in 2024 or <u>Down \$20,930</u> in 1984 voter approved General Fund portion and <u>Down 1.42%</u> year-to-date compared to the same period in 2024 or **Down \$20,930** (March 2025 processing through February 2026 processing).

- Five of the top fifty remitters went unprocessed for an average total of \$52,419 and three of the previous four unprocessed did not have balances close to twice their average this month for an average total of \$29,295. The top fifty remitters represent 53.4% of tax receipts. This is less than the same month a year ago.
- Current activity suggests 1984 voter approved General Fund portion of Sales Tax for 2025 will end the year at 19,014,291 which is at 93.41% of budget or \$1,341,959 below 2025 general revenue Fund 101 budget of \$20,356,250 and \$76,410 below 2024 actual. However, this is just the first month of the year and it is historically a month that is below average in receipts.

Trend Lines

The 3-Month trend line <u>increased</u> 0.21% this month and the 12-Month trend line <u>increased</u> 0.63% decreasing the now positive gap from +2.42% to +2.00%. The trend lines continue to indicate an increasing growth in sales tax related spending.

While there is some concern about the low remittance this month; this concern is reduced when you look at the break down by actual economic periods. Given that actual economic activity is up 5.62% year-to-date, it appears more likely that processing at the State was impacted by how the calendar days fell this month. Next month's processing is expected to improve the current results.
