Answer: The Collector's Office part-time staff estimate is approximately \$100,000

7. What is the tentative start date of this engagement?
Answer: September 1, 2025
8. What is the work location of the proposed candidates?
Answer: Various departmental location with in Greene County Offices.
9. Is this a new contract or are there any incumbents? If there is an incumbent, could you please let us know the incumbent name and pricing and are the incumbents eligible to submit the proposal again?
Answer: The current contracts are held with Penmac and Kelly Services.
10. Are there any pain points or issues with the current vendor(s)?
Answer: No
11. Could you please share the previous spending on this contract, if any?
Answer: \$1.3M spent between two awarded vendors during the current contract period 7/1/21 to current
12. Is there any mandatory subcontracting requirement for this contract? If yes, Is there any specific goal for the subcontracting?
Answer: No
13. How many positions were used in the previous contract (approximate)?
Answer: From County Clerk's office- 6-8 positions during election season and up to 30 positions for election judges.

The Collector's Office varies depending on need and time of year. Approximately 3-6 positions at any given time.

Additional offices and departments may utilize this contract as well.
14. How many positions will be required per year or throughout the contract term?
Answer: Positions vary throughout the year on an as-needed basis.

15. If the resources we provide at the time of proposal submission are not available at the time of a potential contract award could vendors replace them with equally qualified resources?
Answer: Yes, if a proposed candidate is unavailable at the time of contract, the vendor may substitute another candidate with equal or greater qualifications and skillset, subject to approval.

Collector's Office pay range is \$15-\$17 per hour.

Answer: All work is conducted onsite.

Answer: Certification is required and we do not require the individual to provide any equipment.
39. How will performance issues or replacements be communicated and resolved? Is there a standard protocol?
Answer: County Clerk Office - Supervisor will communicate directly with both employee and agency
40. Will Greene County allow multiple vendors to be awarded and operate concurrently under this contract?

41. Does the County provide any orientation or training to temporary workers at the start of assignment?
Answer: Yes
42. Will Greene County supply work-related equipment (e.g., uniforms, tools, safety gear) for certain roles?
Answer: Greene County Building Maintenance department will supply tools and safety gear; however, Building Maintenance department will not supply uniforms for temporary employees.

The Highway department will supply safety glasses and a safety vest. The Highway department does not supply tools except for the mower they will operate.

Answer: The County does not have a preference for background checks and drug tests that the agency performs.
44. Can you confirm if pricing will be evaluated purely on markup or overall cost including additional services?
