Sales Tax Received in September 2025 (August 2025 processing)


County's General Sales Tax is <u>Down 4.47%</u> for this month compared to the same month in 2024 or <u>Down \$73,518</u> in 1984 voter approved General Fund portion and <u>Up 1.89%</u> year-to-date compared to the same period in 2024 or <u>Up \$179,103</u> (March 2025 processing through February 2026 processing).

- Three of the top fifty remitters went unprocessed and one of the top three reported less than two-thirds of their average amount for an average total of \$107,087 and one of the previous four unprocessed did not have balances close to twice their average this month for an average total of \$7,276. The top fifty remitters represent 52.79% of tax receipts.
- Current activity suggests 1984 voter approved General Fund portion of Sales Tax for 2025 will end the year at 19,403,729 which is at 95.32% of budget or \$952,521 below 2025 general revenue Fund 101 budget of \$20,356,250 and \$313,028 above 2024 actual.

Trend Lines

The 3-Month trend line <u>decreased</u> 0.07% this month and the 12-Month trend line <u>increased</u> 0.29% decreasing the now positive gap from +0.43% to +0.07%. We continue to see sideways movement in the 3-month trend line while the 12-month trend line continues to close the gap. The changes in the national/global economy and consumer sentiment were not anticipated when the 2025 budget was compiled.
