





Greene County Clerk's Office partners with NaviLens to enhance accessibility for blind and visually impaired residents

SPRINGFIELD, Mo. – Greene County Clerk Shane Schoeller is proud to announce a partnership with NaviLens and Mary's Braille International to implement cutting edge accessibility technology at the Greene County Clerk's Office. This initiative underscores the county's commitment to ensure that all residents, including those who are blind or visually impaired, can independently access government services.

NaviLens is an accessibility technology that uses distinctive multi-colored codes, similar to QR codes, to help individuals who are blind or have low vision navigate spaces independently. The NaviLens system includes two free mobile applications, NaviLens and NaviLens GO, available for both iOS and Android devices.



When users point their smartphone in the general direction of a NaviLens code, the app instantly detects it and delivers audio information, including directions, distances, and details about the location. The technology supports more than 40 languages.

NaviLens codes can be detected instantly without needing to focus the camera, from distances of up to 50 feet, at wide angles, and in any lighting condition. The technology translates visual signage into audio messages, providing users with real-time information about their surroundings.


"It's important to me that we prioritize making government services accessible to everyone," said Shane Schoeller, Greene County Clerk. "Whether citizens are visiting our office to vote, access records, or conduct other business, NaviLens will help ensure they can navigate our facilities independently and with confidence."

Mary's Braille International is based in Willard, Missouri and has also implemented the NaviLens technology in several locations throughout the Springfield area, including the History Museum on the Square.

NaviLens technology has also been deployed at major transit systems worldwide, including the New York City MTA, the Los Angeles Metro, and the Barcelona transit system, as well as by major consumer brands seeking to make product packaging more accessible. The Greene County Clerk's Office joins a growing network of government offices and public spaces committed to universal accessibility.

The Greene County Clerk's Office is located at 940 N Boonville Avenue, Room 113, in the Historic Courthouse in Springfield, Missouri. Residents are encouraged to download the free NaviLens app and experience the technology during their next visit.
