Sales Tax Received in June 2026 (May 2026 processing)

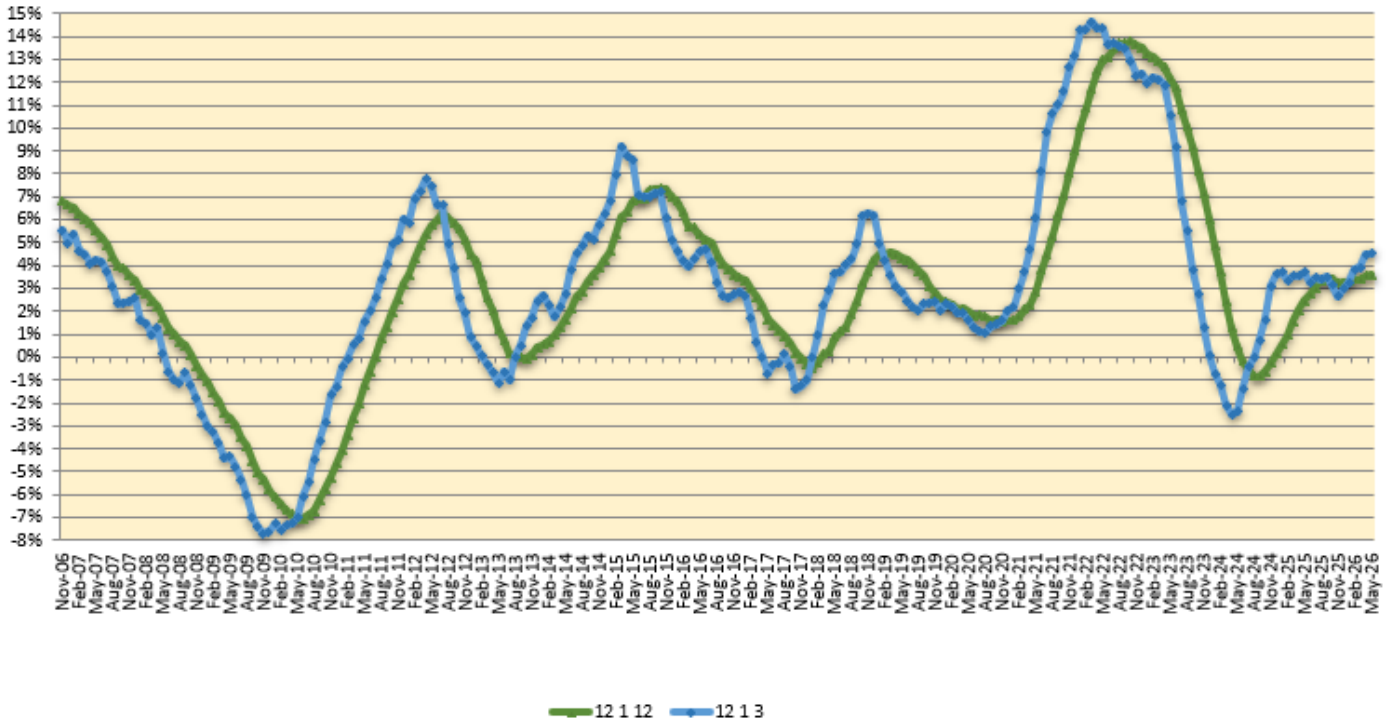
County's General Sales Tax is **Down 3.78%** for this month compared to the same month in 2025 or **Down \$68,706** in 1984 voter approved General Fund portion and **Up 4.76%** year-to-date compared to the same period in 2025 or **Up \$302,281** (February 2026 processing through January 2027 processing).

- Two of the top fifty remitters went unprocessed for an average total of \$17,707 and one of the previous month's three unprocessed did not have close to twice their average this month for a total of \$13,511. The top fifty remitters represent 53.60% of tax receipts.
- Current activity suggests 1984 voter approved General Fund portion of Sales Tax for 2026 will end the year at \$20,036,316 which is at 103.28% of budget or \$636,316 above 2026 general revenue Fund 101 budget of \$19,400,000 and \$319,996 above 2025 actual.

Trend Line

The 3-Month trend line **increased** 0.06% this month and the 12-Month trend line **increased** 0.02% the trend lines now have a positive gap of 0.96%. We are currently in a period of expected growth in sales tax receipts.
