Highway Department Report

Rick Artman director of Highway, Handed out a report to the Commissioners with updates in regards to the different Crews within the highway department. District 1 Crew updates: Crew have been cleaning ditches and culverts and had to replace drainage pipes with all the recent flooding, talked about all the bullet points in the hand out under District 1. District 2 crew's updates, been repairing damage from the floods, repaired a pipe that was damaged in the flooding. Various areas of storm clean up. Mr. Artman spoke on all the bullet points under the district 2 header on the hand out. The County Wide Maintenance Crew Shoulder widening Asphalt Overlay in district 1 20.14, Special Project Crew-Box Culvers/Bridge Maintenance highlighted he bullet points from the hand out that was presented to the commission, Shop and Warehouse updates went over the acquired and distributed parts and materials in the service center. Went over order totals that are located in the handout. Traffic Control updates performed routine sign maintenance by installing the new 9' street signs in both districts. Sent 3 members to Iowa for striping training which was paid for by the striping company. Safety updates 3 vehicle accidents 1 sheriff, Highway, 1 reportable injuries Nick S. Slipped from a boon truck but wasn't seriously injured. Seasonal employees recently attended training of various sorts. Equipment Rodeo where guys get to show their skills that they use every day. Mr. Artman went through the rest of the hand out in detail.

OEM Report

Mike Dixon OEM Director, presented the commission with the May end of Month report. Thanked Larry Woods for being the interim director and doing a great job filling in while looking for the new director. Our goal is to be the most disaster resilient community in the country. Has been working with Good Morning Springfield breakfasts and meeting business owners and leaders and is excited to be working with them. Received EMAP recertification notification OEM is one of 41 local jurisdictions who have the accreditation. Highlighted the Commission with certain events that are happening at OEM. Explained. OEM's role in disbanding the homeless camp and the different services being provide by the community to the homeless. Commissioner Cirtin wanted specifics on what we are doing to help. Mr. Dixon explained there are service providers being brought in, mental health, housing help, pet help, legal help, and

Resource Management Report

Kevin Barnes Resource Management Director

We participate in national Flood Insurance Program which requires a visit structures from time to time, there is only one structure that is considered a complete loss which is the Scott House out on farm road 93. Resource Management will work with the Scott family and their insurance to make the structure safer from flooding issues in the future. Springfield Laundry did drill the deep wells last month and the invoices have been paid and turned in for reimbursement before the dirt fund dries up. Judicial update Talked with Judge Borthwick, the July 3rd meeting will be in the HC. They are carpeting and painting and the mill work will come in next week, the jury chairs are taking longer than expected however Mr. Barnes gave option of different chairs however they want to go with the original chairs as the fabric is more durable. Code Compliance plans on demolishing another property. Building Ops has made some new hires in HVAC and Plumbing.

County Geologist Report

Marr Forir Cave Specialist and Geologist. Cave Hand out provided to the commission with pictures. Photographs are the newest discovery made, it is a shard of glass from volcanic ash from Yellowstone explosion. Went on to talk about the gravity of the discovery and how it is a very big deal. Furthest Ash find from Yellowstone and will help answer why certain animals are resented in the caves. This is about 2-3 years out before a paper will be released about this find. Mr. Forir talked about what would have been present in Greene County around the Yellowstone event and give us a better idea of the geomorphic history as well as the geology of the county. Bob Cirtin asked if this event would bring visitors to look at this piece of glass, and would increase spending to the community. Matt Forir confirmed it would. Mr. Forir went on to explain the importance of the find to the Commission. Talked about some donations that the cave museum will be receiving. Reminded Commission will be out next month as will be out of the country.

Building Regulations Division Report
