John Wilson was asked to present to the Commission his requested agenda item, which was the proposal of a music festival on Jamestown property. He said "Light the Lake" has been held in previous years in Stockton's city park. He said that the attendance number grew to 21,000 people last year, and they need a bigger venue. It would be a two day Christian music festival with a limited number of food vendors, to take place near where Rockin' Rogersville has been held annually. The festival is free to the public. The Commission instructed Wilson to communicate with Chris Coulter regarding developing a proposed contract and to receive information about elements such as insurance coverage. Once Wilson drafts a contract, he can present it to the Commission for a vote.

Budget Officer Jeff Scott presented for Commission signature the bond documents pertaining to the Sept. 13, 2018 closing of \$64,470,000 Certificates of Participation (Capital Projects) Series 2018. These documents were prepared by Armstrong Teasdale and reviewed by Scott. Scott went over the fees that are included in the agreement. He presented a transcription book that contained about 19 different agreements related to the capital bonds, and four agreement documents with BOK Financial, which is the trustee. Scott confirmed that all numbers within the documents were correct. Commissioner Bengsch made a motion to approve the Certificates of Participation (Capital Projects) Series 2018. The Commissioners proceeded to sign the related documents, with Assistant Megan Applegate acting as notary and County Clerk Shane Schoeller certifying documents as needed.
