Commission received a letter of recommendation for Kris Schell to the Workforce Development Board. Commissioner Hough moved to approve the appointment to the workforce development board. Commission tabled the action item listed "Robert Leatherman Tax Abatement Request"

Human Resource Director Mailyn Knight reminded the Commission of the upcoming flu shot clinics that will occur on October 11<sup>th</sup> and 12<sup>th</sup>. Knight informed the Commission based on the October 3<sup>rd</sup> Economic Development presentation unemployment rates were at an all-time low of 3.3% annually and 2.7% in Springfield. Human Resource Specialist reminded the commission that Employee Appreciation day will be held on October 10<sup>th</sup> and Amburg Entertainment will provide all services including set up and tear down.

Commissioner Hough asked HR Director Knight when the last time we went out to bid for our insurance. Knight stated 2010. Purchasing Director Chris Mericle explained to Hough that when you are in a pool you do not have to bid. Commissioner Hough expressed his desire to look into another bid to make sure we are getting the best rates possible.

Deputy Budget Officer Tina Phillips updated Commission that as of today the Wright Auto property is under budget, and it is anticipated to be under budget even after dirt works in completed. Phillips informed the Commission that there was a real-estate credit from the Wright Auto property and that she will discuss with Auditor Cindy Stein the best option on how to handle the credit.

Budget Officer Jeff Scott and Deputy Budget Officer Mike Cagle updated the Commission on a new state statue in regards to reimbursement of pretrial services.

County Administrator Chris Coulter reminded the Commission that October 8<sup>th</sup> is Columbus Day and all County Offices will be closed.

Public Information Officer Donna Barton notified the Commission that currently 20 seats are filled for the Ag. Tour. On 09/26<sup>th</sup>. The Weaver School drive collected several thousands of items for students. Barton continues to work with IS to create a blog.
