Resource Management Director Kevin Barnes introduced County Geologist Matt Forir to the new commissioners. Forir told the Commission about Riverbluff Cave, the Missouri Institute of Natural Science museum, and his geology work with the county. Barnes gave updates about various projects around campus.

Chief Juvenile Officer Bill Prince invited the commissioners to visit the juvenile department facilities. He also updated them about a new position in partnership with 4-H. The county will pay half the salary of the 4-H officer.

E-911 Assistant Director JR Webb gave an update, as well. He provided a document showing year-end statistics (Exhibit A).

County Administrator Chris Coulter told the Commission that he's been communicating with the Watershed Conservation Corps about utilizing its services to mitigate some properties that might feature native plants, as well as work with the Corps in the development process to facilitate the development of low-impact developments. Coulter said that Pretrial Services was working on an assessment for the Arnold Foundation program. He also noted that an interview for a prospective medical examiner was coming up soon.

Public Information Officer Donna Barton provided the legislative priorities brochures for review. She also went over the schedule for the Salute to Legislators.

Staff and Commissioners review the calendar for the upcoming two weeks.
