SUBJECT: Appointment of Ex-Officio Commissioner for Greene County, Missouri, for the commencement of a certain judicial foreclosure proceeding for Lots 1 and 2 Final Plat Colonies and Lot C12 of the Final Plat of Jamestown Development

WHEREAS, Greene County is seeking to collect certain past due Neighborhood Improvement District (NID) assessments which have been levied and are outstanding with respect to Lots 1 and Lot 2 Final Plat of the Colonies and Lot C-12 in the final plat of Jamestown Development which sums were assessed pursuant to RSMo. §67.469; and

WHEREAS, Greene County seeks to file a judicial foreclosure proceeding with the Greene County Circuit Court with respect to lots listed above, to accelerate amounts due for assessments on those lots and to commence a sheriff's sale for the liquidation of properties in satisfaction of the outstanding liens for the NID assessments authorized pursuant to RSMo. § 67.469; and

WHEREAS, RSMo. §49.280 provides the County Commission may, by Order, appoint an Ex-Officio Commissioner to deal with interest in real estate; and

WHEREAS, the County Commission approves the commencement of the lawsuit on behalf of the County for liquidation of certain property in satisfaction of certain unpaid NID assessments; and

WHEREAS, the Greene County Commission elects to appoint Chris Coulter, its Ex-Officio Commissioner, to execute all documents pertaining to the Petition as described above and any all ancillary documents with respect to disposition of the lots as specified by the Court.




NOW, THEREFORE, in accordance with the above and foregoing Greene County shall commence the action in the Greene County Circuit Court to foreclose its interest in the parcels of property listed above accelerate any amounts due and have Chris Coulter authorized to do so.

IT IS HEREBY ORDERED:


Chris Coulter is hereby appointed as an Ex-Officio Commissioner of Greene County to enter into and to prosecute the litigation as specified above and act on behalf of the County Commission.
