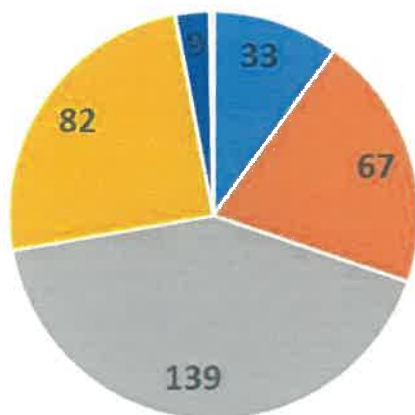

2020 Summary

- **4062 calls** reporting deaths to Medical Examiner's Office; investigators on call 24/7 to receive calls and respond to scenes
- **868 death certificates** signed
- 48 toxicology only cases
- 331 postmortem examinations
 - 214 full autopsies
 - 99 external examinations
 - 18 partial autopsies
 - **282 autopsy equivalents** (considers 2 external examinations equivalent to the work of 1 autopsy)
- **Turnaround time** for postmortem reports
 - **28 days average** completion time
 - 92.7% of reports completed within 60 days
 - 96.7% of reports completed within 90 days

Manner of Death for Postmortem Cases



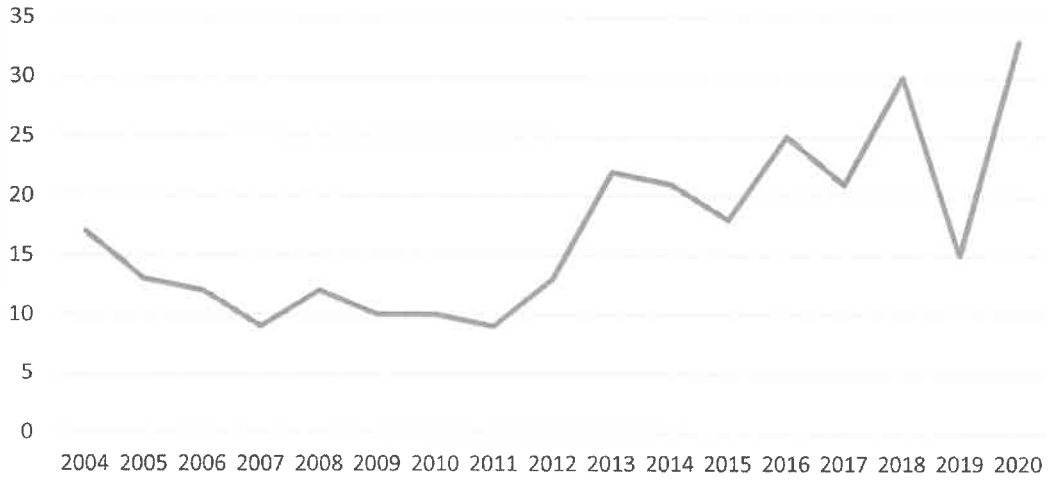
■ Homicide ■ Suicide ■ Accident

Notable Subcategories of Postmortem Cases

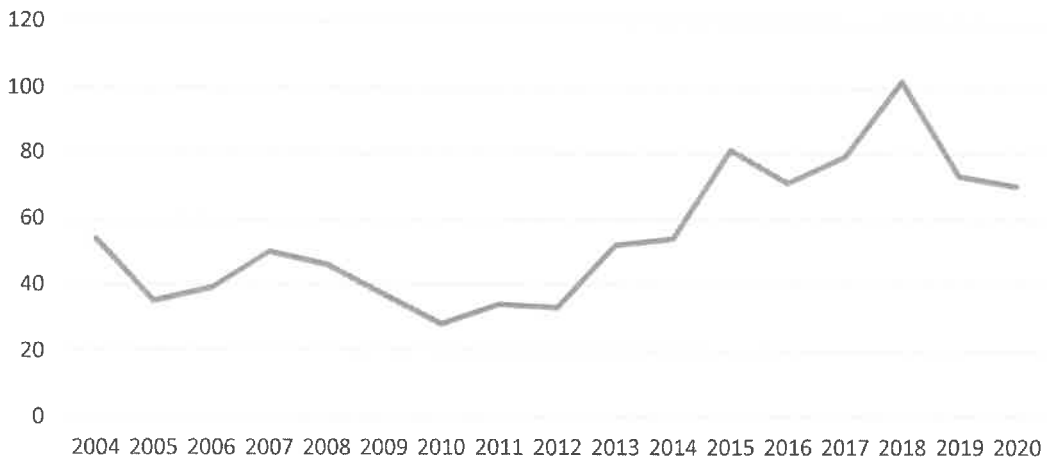
- 107 drug intoxication deaths
- 75 methamphetamine and/or fentanyl deaths
- 72 gunshot wound deaths
- 43 hypertensive and/or atherosclerotic cardiovascular disease deaths
- 34 motor vehicle fatalities
- 7 deaths age 1-17
- 6 infant deaths (12 months or less)
