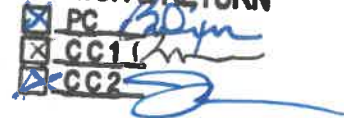


Dear Ms. Payne,
