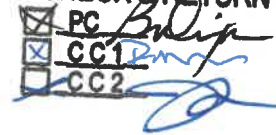

3. All preventive exam goals are claims verified. Allow 2-3 weeks after claim has been submitted to show as "completed" on myCigna.com.\*\*
4. Employees currently receiving coverage for diabetic supplies (lancets and test strips) will be required to achieve 300 points to continue the 100% coverage effective July 1, 2022 for all plans.
