#### Items for Consideration and Action by the Commission

1. Support Letter—NAP Tax Credit—Chris Whitehead, Boys & Girls Clubs of Springfield
  - *The letter of support is to accompany a grant application for a tax credit. The Boys and Girls Clubs of Springfield are hoping to increase the amount of equipment as well as offer a variety of programs for youth. They plan to conduct classes regarding financial literacy, self confidence and self esteem, community success activities to name a few. Mr. Whitehead explained the programs for youth regarding "money matters". They plan to offer a mentor partnership to assist with homework as well as a 2000 hour community service program. Evangel University has given 90 scholarships for Weaver Elementary students to be able to access the Clubs. The letter of support was circulated for signature.*
2. NAP Tax Credit—Equi-Librium Therapy Center, Inc.
  - *This is a Neighborhood Assistance Program with the Equi-Librium Therapy Center that requires a signature from the Greene County Presiding Commissioner. Commissioner Cirtin has reviewed the grant and signed his portion of the grant document.*
